**FINANCIAL REGULATIONS
OF THE WORLD FEDERATION OF ACROBATIC AND SWING DANCES**

1. General Provisions

1.1. The Financial Regulations of the World Federation of Acrobatic and Swinging Dances (hereinafter referred to as the Regulations) establish the amount of fees (excluding entrance and membership fees) and payments related to the conduct of the World Federation of Acrobatic and Swinging Dances (hereinafter referred to as WFASD) charter activities.

1.2. In accordance with the Regulations, the following are subject to payment:

- fees for registration in the WFASD system;
- entry fees for participation in competitions;
- fees for the right to host international competitions.

2. Fees for registration in the WFASD system and Entry Fees

2.1. The annual registration fee in the WFASD system is:

- for athletes - \$10.
- for judges - \$15.

2.2. Registration fees in the WFASD system are paid annually by March 1st of the current year to the WFASD settlement bank account.

2.3. The amount of entry fees and the procedure for their payment are established by the competition organizers independently. However, the amount of entry fees should not exceed \$10 per athlete per competition day. Entry fees are the income of the competition organizers.

3. Fees for the right to host international competitions

3.1. The amount of fees for the right to host the World Championship is:

4.3 The Prize payout amount is indicated inclusive of tax. Prize money is paid to athletes from the WFASD funds.

5. Payments for Conducting Training Seminars

5.1 The amount of payments to Lecturers engaged for conducting training seminars is \$100 per day of work, including tax. Tax withholding is carried out according to the rules of the tax legislation of the paying party.

6. Payments related to the organization of competitions

6.1 The conditions for athletes participating in the competitions provided for in the WFASD Calendar Plan, are approved by the WFASD Presidium and posted on the official WFASD website.

6.2 WFASD covers the following expenses for judges approved by the WFASD Presidium for servicing competitions:

- travel expenses by air or rail (economy class);
- transfer from the airport /railway station to the hotel and back;
- entry visa costs;
- accommodation in a single hotel room not higher than 4*, with breakfast (a hotel room is provided for the competition days plus one day);
- payments for each competition day in the following amounts:

The amount of the fee is indicated inclusive of tax. Tax is withheld according to the rules of the tax legislation of the paying party.

Providing the referees with two meals a day during the competition is the responsibility of the competition organizer.

7. Payments to the WFASD Officials

7.1. For the purposes of the Regulations, the WFASD officials are defined as: the WFASD President, members of the WFASD Presidium, the WFASD Executive Director.

7.2. The following expenses related to the fulfillment of duties stipulated in the WFASD Statutes should be covered by the WFASD to the WFASD officials:

- travel by air or rail;
- transfer;

- visa processing;
- accommodation in a single hotel room with breakfast.

8. Final Provisions

8.1. The approval of the Regulations, the amendments to them and their revocation shall be subject to approval by a decision of the WFASD Presidium.

8.2. The Regulations shall come into force from the date of publication on the official WFASD website.

8.3. The amounts of fees and payments established by the Regulations shall be subject to review no more than once a year.
